PRINCIPAL ACTIVITIES

The principal activity of Medlife Insurance Ltd. (the Company) is the sale of life assurance policies.

RESULTS

The income statement of the year is presented on page 12 of the financial statements. The Company shows profits before taxation charge in the amount 6.91 Mio USD in 2021 (2020: 7.08 Mio USD).

DIVIDENDS

On 12th November 2021, the Board of Directors approved the payment of an interim dividend from the profits of 2020 and 2021 of USD 0.96045 per share (2020: USD 0.79096 per share), amounting to USD 8.500.000 (2020: USD 7.000.000) in total.

All of them were members of the Board of Directors throughout the year ended 31 December 2021. Mr. Peter Hronovsky resigned from the Board of Directors on 31 March 2022. 




